#### The need for managed Office 365 signatures

Goldfish, at the time, did not have a system in place to centrally manage Office 365 signatures across the whole organization. From a brand and compliance perspective, this meant that users were utilizing their own designs that did not comply with corporate standards. It was clear that this needed to be addressed. However, the IT department was relatively small, so setting up a companywide policy on email signatures and implementing it would take a lot of time, plus there are inherent limitations managing signatures through Office 365 Transport Rules alone.

#### Searching for the answer

"We simply needed a service that would make managing Office 365 signatures easy," said Sonny Gillissen, Infrastructure/Technical Consultant at Goldfish. "I searched for possible solutions online which could facilitate our email signature management needs, wrote a proposal to the organization's decision makers and, after a short discussion, we chose Exclaimer Cloud - Signatures for Office 365."
